What is this product?

Type

The SICAV is a Luxembourg Investment company subject to the provisions of Part I of the Law of 17 December 2010, relating to undertakings for collective investment in transferable securities (UCITS).

Term

There is no maturity date. The SICAV has been established for an unlimited period of time. Natam may terminate the SICAV and the Sub-Funds early, following the procedures described in §23 and §24 of the Prospectus.

Objectives

Investment objective The objective of the Sub-Fund is to achieve returns in excess of those which can normally be achieved through monetary instruments while trying to maintain a low risk profile also taking into account the need to promote environmental social and governance characteristics on the investments (ESG factors), mitigating the relevant sustainability risk.

Investment policies The Sub-Fund invests in deposits, money market instruments as well as fixed and variable bonds denominated in Euro issued mainly by governments and supranational bodies.

Derivative instruments, which are financial contracts whose value depends on the market price of a reference asset, can also be used for investment purposes provided that the total commitment does not exceed, at any moment, 20% of net asset value of the Sub-Fund.

The "ESG features", according to art.8 of EU Regulation 2019/2088, are implemented through a two-level approach:

1. an average portfolio ESG rating, determined with a proprietary model, which must be kept above the level of 65;
2. a set of specific restrictions and investment limits identified to promote sustainable investments.

The specific investment limits and environmental characteristics are detailed in the specific paragraph "Sustainability criteria in investment decisions" in Section II of the Prospectus. Regarding the Taxonomy Regulation, the underlying investments do not take into account the EU criteria for environmentally sustainable economic activities.

Benchmark uses Discretion is allowed with respect to the benchmark. The Investment manager may invest in financial instruments not included in the benchmark in order to take advantage of specific investment opportunities. This active management approach involves a deviation from the reference index which can be significant.

The Sub-Fund is not intended to track the benchmark

Redemption and Dealing Investors may redeem their shares on any business day for Luxembourg banks provided that the stock exchange in which the shares are tradable is open for trading and that it is possible to cope with the orders. They cannot switch their shares in those of another Sub-Fund and/or Class within the SICAV.

Distribution Policy All income is, normally, reinvested.

Intended retail investor

This share class is intended for investors with a short-term investment horizon, with a basic knowledge of the product, who can bear limited losses and having preference for products complying with the ESG factors.

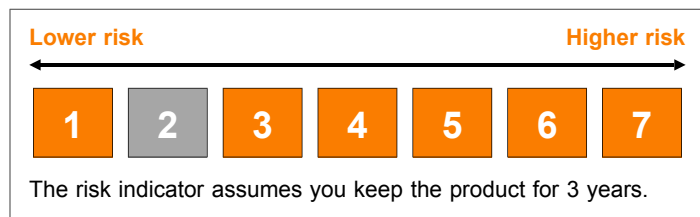

The information contained in this document is specific to Euro Bonds Short Term. However, the Prospectus, annual and half-yearly reports are prepared for the SICAV as a whole.

The SICAV consists of separate Sub-Funds with segregated liabilities. This means that the assets of a Sub-Fund will not be available to meet the claims of a creditor made against another Sub-Fund.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the

product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This means that potential losses due to the future performance of the product are rated a low level and that adverse market conditions are very unlikely to affect the sub-fund's ability to return the initial capital.

This product does not include any protection from future market performance so you could lose part or all your investment. The significant risks not detected by the synthetic indicator, are detailed in the "Main risk factors" section of the relevant Sub-Fund Appendix of the Prospectus.

Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable: this type of scenario occurred for an investment between December 2019 and December 2022.

Moderate: this type of scenario occurred for an investment between October 2016 and October 2019.

Favourable: this type of scenario occurred for an investment between November 2021 and November 2024.

What happens if NATAM Management Company S.A. is unable to pay out?

In the event of Natam's insolvency, the assets of the SICAV will not be affected. The assets of the SICAV are held in safekeeping by the Depositary, that is required by law to segregate its own assets from the assets of the Sicav.

If the fund is not able to pay you out what is due, you may lose your entire investment. Losses are not covered by an investor's compensation or guaranteed scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

The Recommended holding period (RHP) is 3 years but investors can request the redemption of their shares on any business day for Luxembourg banks provided that the stock exchange in which the shares are tradable is open, without paying any redemption fee. The RHP has been selected on the basis of a quantitative and qualitative analysis considering the strategy, fees and risk profile of the product.
